Section 1

The applicant must be a United States citizen as well as:

- An owner of a pest control company that is a member in good standing with the NMPMA.
- An employee who is currently working for an active member in good standing with the NMPMA.
- A natural, adopted, legal guardian, child, or member of the household of a person who meets the qualifications previously stated.

Section 2

- Accepted as a full-time student as defined by an accredited college/university or
- Currently a full-time student in an accredited college/university.

NOTE: In order for an application to be reviewed, all of the following items must be submitted to the Scholarship Committee in care of the NMPMA Board of Directors at above address before June 1:

1. Properly completed scholarship application, and
2. Whichever pertains:
 - A. High school transcript along with a copy of acceptance letter from college/university you are planning to attend and notarized or verified copy of SAT/ACT test results or
 - B. Most recent college transcript including cumulative GPA.
3. A letter written by applicant containing the following:
 - A. What field you plan to major in or are currently majoring in?
 - B. What are your plans for the future?
 - C. A list of activities-school, extra-curricular and community
 - D. Awards received
4. Letter of recommendation from High School Principal, Assistant Principal or Guidance Counselor from school presently attending or graduated. If already attending college a letter from a professor or your Dean.
